AKTA MAJLIS PERUNDINGAN GAJI NEGARA 2011

PERINTAH GAJI MINIMUM (PINDAAN) 2018

PADA menjalankan kuasa yang diberikan oleh seksyen 23 Akta Majlis Perundingan Gaji Negara 2011 [*Akta 732*], Menteri membuat perintah yang berikut:

Nama dan permulaan kuat kuasa

1. (1) Perintah ini bolehlah dinamakan **Perintah Gaji Minimum (Pindaan) 2018**.

(2) Perintah ini mula berkuat kuasa pada 1 Januari 2019.

Pindaan perenggan 3

2. Perintah Gaji Minimum 2018 [*P.U. (A) 265/2018*], yang disebut “Perintah ibu” dalam Perintah ini, dipinda dengan menggantikan perenggan 3 dengan perenggan yang berikut:

NATIONAL WAGES CONSULTATIVE COUNCIL ACT 2011

MINIMUM WAGES ORDER (AMENDMENT) 2018

IN exercise of the powers conferred by section 23 of the National Wages Consultative Council Act 2011 [Act 732], the Minister makes the following order:

Citation and commencement

1. (1) This order may be cited as the **Minimum Wages Order (Amendment) 2018**.

(2) This Order comes into operation on 1 January 2019.

Amendment of paragraph 3

2. The Minimum Wages Order 2018 [*P.U. (A) 265/2018*], which is referred to as the “principal Order” in this Order, is amended by substituting for paragraph 3 the following paragraph:

“Minimum wages rates

3. The minimum wages rates payable to an employee shall be as follows:

”.

Amendment of paragraph 4

3. Paragraph 4 of the principal Order is amended by substituting for the word “RM1,050.00” the word “RM1,100.00”.
