**PERATURAN-PERATURAN STANDARD-STANDARD MINIMUM PERUMAHAN DAN  
KEMUDAHAN PEKERJA (PUSAT ASUHAN KANAK-KANAK) (PINDAAN) 2020**

PADA menjalankan kuasa yang diberikan oleh seksyen 25 Akta Standard Minimum Perumahan, Penginapan dan Kemudahan Pekerja 1990 [*Akta 446*], Menteri membuat peraturan-peraturan yang berikut:

**Nama dan permulaan kuat kuasa**

1. (1) Peraturan-peraturan ini bolehlah dinamakan **Peraturan-Peraturan Standard-Standard Minimum Perumahan dan Kemudahan Pekerja (Pusat Asuhan Kanak-Kanak) (Pindaan) 2020.**
  
- (2) Peraturan-Peraturan ini mula berkuat kuasa pada 1 September 2020.

**Pindaan peraturan 1**

2. Peraturan-Peraturan Standard-Standard Minimum Perumahan dan Kemudahan Pekerja (Pusat Asuhan Kanak-Kanak) 1990 [P.U. (A) 413/1990], yang disebut "Peraturan-Peraturan ibu" dalam Peraturan-Peraturan ini, dipinda dalam peraturan 1 dengan menggantikan perkataan "**Standard-Standard Minimum Perumahan dan Kemudahan Pekerja**" dengan perkataan "**Standard Minimum Perumahan, Penginapan dan Kemudahan Pekerja**".

**Pindaan peraturan 19**

3. Subperaturan 19(1) Peraturan-Peraturan ibu dipinda dengan menggantikan perkataan "10" dengan perkataan "lima".

EMPLOYEES' MINIMUM STANDARDS OF HOUSING, ACCOMMODATIONS AND AMENITIES ACT 1990

WORKERS' MINIMUM STANDARDS OF HOUSING AND AMENITIES (NURSERIES) (AMENDMENT) REGULATIONS 2020

IN exercise of the powers conferred by section 25 of the Employees' Minimum Standards of Housing, Accommodations and Amenities Act 1990 [Act 446], the Minister makes the following regulations:

**Citation and commencement**

1. (1) These regulations may be cited as the **Workers' Minimum Standards of Housing and Amenities (Nurseries) (Amendment) Regulations 2020**.
  
- (2) These Regulations come into operation on 1 September 2020.

**Amendment of regulation 1**

2. The Workers' Minimum Standards of Housing and Amenities (Nurseries) Regulations 1990 [P.U. (A) 413/ 1990], which are referred to as the "principal Regulations" in these Regulations, are amended in regulation 1 by substituting for the words "**Workers' Minimum Standards of Housing and Amenities**" the words "**Employees' Minimum Standards of Housing, Accommodations and Amenities**".

**Amendment of regulation 19**

3. Subregulation 19(1) of the principal Regulations is amended by substituting for the word "10" the word "five".
