PADA menjalankan kuasa yang diberikan oleh perenggan 25(2)(ab) Akta Standard Minimum Perumahan, Penginapan dan Kemudahan Pekerja 1990 [Akta 446], Menteri membuat peraturan-peraturan yang berikut:

**Nama**

1. Peraturan-peraturan ini bolehlah dinamakan **Peraturan-Peraturan Standard Minimum Perumahan, Penginapan dan Kemudahan Pekerja (Pekerja yang Dikehendaki untuk Disediakan dengan Penginapan) 2021.**

**Pekerja yang dikehendaki untuk disediakan dengan penginapan**

2. (1) Seseorang pekerja asing hendaklah dikehendaki untuk disediakan dengan penginapan di bawah Bahagian IIIA Akta.

(2) Bagi maksud peraturan ini, "pekerja asing" ertinya seorang pemegang Pas Lawatan (Kerja Sementara) yang dikeluarkan di bawah peraturan 11 Peraturan-Peraturan Imigresen 1963 [F.L.N. 228/1963], tetapi tidak termasuk pekhidmat domestik.

EMPLOYEES' MINIMUM STANDARDS OF HOUSING, ACCOMMODATIONS AND AMENITIES (EMPLOYEES REQUIRED TO BE PROVIDED WITH ACCOMMODATIONS) REGULATIONS 2021

IN exercise of the powers conferred by paragraph 25(2)(ab) of the Employees' Minimum Standards of Housing, Accommodations and Amenities Act 1990 [Act 446], the Minister makes the following regulations:

**Citation**

1. These regulations may be cited as the **Employees' Minimum Standards of Housing, Accommodations and Amenities (Employees Required to be Provided with Accommodations) Regulations 2021**.

**Employees required to be provided with accommodations**

2. (1) A foreign employee shall be required to be provided with accommodation under Part IIIA of the Act.

(2) For the purposes of this regulation, "foreign employee" means a holder of a Visit Pass (Temporary Employment) issued under regulation 11 of the Immigration Regulations 1963 [F.L.N. 228/1963], but does not include a domestic servant.
