EMPLOYEES' MINIMUM STANDARDS OF HOUSING, ACCOMMODATIONS
AND AMENITIES (VESTING OF POWERS) (NO. 6) ORDER 2021

IN exercise of the powers conferred by subsection 26(1) of the Employees' Minimum Standards of Housing, Accommodations and Amenities 1990 [Act 446], the Minister makes the following order:

Name

1. This order may be cited as the **Employees' Minimum Standards of Housing, Accommodations and Amenities (Vesting of Powers) (No. 6) Order 2021.**

Vesting of powers

2. Minister vests in—
 - (a) the officers specified in the First Schedule the powers conferred upon the Director General under paragraphs 24C(1)(a), (b), (c) and (e), subsection 24C(3), sections 24FA and 24FB, section 27 and subsection 28A(2); and
 - (b) the officers specified in the Second Schedule the powers conferred upon the Director General under paragraphs 24C(1)(a), (b), (c) and (e), and section 27.
